Learning objectives

- Students can explain the objectives and principles of ITSM.
- Students can explain the core processes, functions, and roles of ITSM.
- Students are able to carry out core ITSM processes and functions.
- Students are able to assess the applicability of ITSM practices in different contexts.

Course content

For the operations of IT applications and infrastructure, which is responsible for a large part of a company's IT costs, most companies use 'good practice' IT service management (ITSM) frameworks that define the required processes, functions and roles. ITSM is defined by Conger et al. (2008) as focusing on "defining, managing, and delivering IT services to support business goals and customer needs, usually in IT Operations" (p. 1). ITSM has become increasingly important as information systems play an essential role in public and private sector organizations (Marrone, & Kolbe, 2011). With the increased emphasis on IT governance, organizations need to ensure that they have effective processes and skilled staff in place to manage their significant investment in IT infrastructure. The IT Infrastructure Library (ITIL®) is recognized as such a good practice framework for ITSM and is globally adopted in public and private sector organizations.

In this course, students will get to know the operational processes, functions and roles that are commonly applied for ITSM. In particular, the course will cover the individual building blocks of the IT Infrastructure Library, including Service Strategy, Service Design, Service Transition, Service Operation, and Continual Service Improvement.

Apart from presenting theoretical concepts, this course includes a one-day simulation game, in the course of which students will experience the presented practices and roles "in action". Further, invited practitioners will share first-hand insides into ITIL implementation projects.

This course addresses students that consider jobs that relate to the management of IT infrastructure and applications, for example in company's IT departments and startups, or to the management of IT outsourcing arrangements.



The content of the course prepares students for taking the ITIL Foundations Certification exam that students can take voluntarily and at their own cost. This certification is a standard in IT related job markets to proof ITSM qualification.

Course structure

During the first half of the semester, students will watch online lectures and document their learning progress. Within the break, students will participate in a one-day business simulation game. The Apollo 13 Simulation Game lets students experience the application of ITSM processes and functions in a team scenario. Further, a guest lecture will provide the students first-hand insights into ITIL implementation projects. The block session during the break will further include a roundup and an exam preparation. The final exam will be held shortly after the break.
