Course content

Aim of this course is to teach students how business process management technologies can be used to develop process automation and monitoring solutions.

More specifically, the course will help students to achieve the following learning objectives:

- Students understand and can create business process models
- Students understand and can create decision models
- Students are able to automate business processes and decisions using an existing business process management technology
- Students are able to create user forms as well as integrate external services into a business process
- Students are able to analyze the execution of a business process using process mining
- Students have a basic understanding of business process monitoring

Course structure

The course will be conducted on a weekly basis. Lectures will be combined with practical exercises closely aligned to the lecture. Moreover, a team project will be conducted.
