Course information

Course prerequisites

Students must be willing and able to attend all course elements.

There are no other, specific prerequirements.

Learning objectives

- Students know relevant theories in organization studies and information systems research in order to inform their own work in the business innovation domain.
- Students develop an in-depth understanding of one selected theory by analyzing it for their term paper.
- Students can apply the chosen theoretical angle to clarify and strengthen the potential theoretical contribution of their own research.

Course content

Innovations are predominantly developed in and commercialized by organizations. A better understanding of organizations and of how organizational arrangements affect innovation is therefore a primary concern for all kind of studies in business innovation. This is particularly true in times of accelerating digitalization that changes organizations, their arrangements and value creation and appropriation processes at a unprecedented pace.

Research in business innovation seeks a deep understanding of these evolving and constantly changing phenomena. Theory may act as a guide in these endeavors and thus support the understanding and design of business innovations. Theory plays a crucial role for the publication of research results.

In this course, we address what theory is and how we can use it for research.

Examination-aid rule Term papers

Written work must be written without outside help according to the known citation standards, and a declaration of authorship must be attached, which is available as a template on the StudentWeb.

Documentation (quotations, bibliography, etc.) must be carried out universally and consistently according to the requirements of the chosen/specified citation standard such as e.g. APA or MLA.

The legal standard is recommended for legal work (cf. by way of example: FORSTMOSER, P., OGOREK R., SCHINDLER B., Juristisches Arbeiten: Eine Anleitung für Studierende (the latest edition in each case), or according to the recommendations of the Law School).

The reference sources of information (paraphrases, quotations, etc.) that has been taken over literally or in the sense of the original text must be integrated into the text in accordance with the requirements of the citation standard used. Informative and bibliographical notes must be included as footnotes (recommendations and standards e.g. in METZGER, C., Lern- und Arbeitsstrategien (latest edition)).

For all written work at the University of St.Gallen, the indication of page numbers is mandatory, regardless of the standard chosen. Where page numbers are missing in sources, the precise designation must be made differently: chapter or section title, section number, article, etc.

Active classroom participation

In the "Active classroom participation" examination form, regular participation in class is assessed.

The assessment criteria can be as follows:

- Requests to speak enrich the discussion (productive) / requests to speak disturb the discussion (counterproductive);
- Requests to speak are correct/requests to speak are incorrect;
- Requests to speak are frequent/average/rare;
- No requests to speak, but students follow the lesson/no requests to speak and students do not noticeably follow the lessons.

Examination content

The participants have to write and present a term paper of up to 5 pages that responds to the following two tasks:

- (1) Analyze and describe a selected theory (4.0-4.5 pages). Focus on such aspects as (you do not have to address everything):
 - Central constructs and arguments
 - · Unit of analysis
 - Underlying assumptions
 - Boundary conditions
 - o ...
 - (2) Link the theory to your own work (0.5-1.0 page). Consider such questions as:
 - How can the theory clarify your phenomenon?
 - How can researching your phenomenon advance the focal theory?
