Learning objectives

Knowledge & Understanding

During this course successful students will acquire knowledge and understanding of:

- 1. the key theories trying to understand and explain the effects of the use and dissemination of ICT on political communication and participation of citizens,
- 2. the most important opportunities and risks of digitisation for democratic processes.

Transferable Skills

After successful completion of this course students will be able to:

- 1. use the theoretical and empirical insights presented during the course to assess and interpret the digital behaviour of citizens,
- 2. use the theoretical and empirical insights presented during the course to critically assess central studies of the social and political sciences on the course topic,
- 3. use the theoretical and empirical insights presented during the course when addressing some of the key problems in the field effectively, systematically and independently.

Course content

Our communication is becoming increasingly networked and interactive. The use of internet-based information and communication technologies (ICT) expands the available repertoire for both individuals and political institutions. These new communication possibilities enable what we call "digital citizenship": people in a society with access to digital and networked media (provided by ICT) can exercise their citizenship role with the help of digital technologies.

The role of internet-based information and communication technologies for the political participation of citizens has been a core topic of political communication research for around two decades. Numerous studies examine whether and under which



conditions the optimistic assessment of the mobilizing effect of ICT applies. Most of these studies were conducted in Western democracies and can therefore provide solid insights into the potential of ICT in established democracies. At the same time, they reflect a western-oriented understanding of politics and participation. In contrast, political and cultural contexts such as those found in sub-Saharan Africa (SSA) have so far been neglected. In view of the rapid spread of ICT, especially through mobile phones, and its innovative application in everyday life (see e.g. the crowdsourcing platform Ushahidi), regions like SSA are extremely important for our understanding of ICT.

In this seminar we want to (a) ensure the level of knowledge about the effects of ICT on political communication and participation in Western democracies; and (b) identify the contextual factors that are critical to understanding the impact of ICT on political communication outside the OECD world of established democracies.

Course structure

The course is organized in a seminar format and focuses on the introduction and in-depth discussion of the required reading, whereby the active preparation of the texts and the participation of all course participants in the discussion is expected. In each session, a group of students will briefly introduce the texts and supplement / expand the perspective with independently researched material on the topic. Additional input on the respective main topics and further examples are prepared by the lecturer and discussed during the respective session.

The aim is to (a) secure the state of knowledge with regard to the effects of ICT in established democracies for each subject area, and (b) develop concrete expectations with regard to the effects of ICT in SSA.

In teaching and research, she represents a modern understanding of comparative political science, which recognises the increasing interconnectedness of politics, economies and societies in a globalised and digitised world. Term papers

Term papers must be written without anyone else's help and in accordance with the known quotation standards, and they must contain a declaration of authorship which is a published template in StudentWeb.

The documentation of sources (quotations, bibliography) has to be done throughout and consistently in accordance with the chosen citation standard such as APA or MLA.

For papers in law, the legal standard is recommended (by way of example, cf. FORSTMOSER, P., OGOREK R. et SCHINDLER B., Juristisches Arbeiten: Eine Anleitung für Studierende, newest edition respectively, or according to the recommendations of the Law School).

The indications of the sources of information taken over verbatim or in paraphrase (quotations) must be integrated into texts in accordance with the precepts of the applicable quotation standard, while informative and bibliographical notes must be added as footnotes (recommendations and standards can be found, for example, in METZGER, C., Lern- und Arbeitsstrategien, newest edition respectively.

For any work written at the HSG, the indication of the page numbers is mandatory independent of the chosen citation standard. Where there are no page numbers in sources, precise references must be provided in a different way: titles of chapters or sections, section numbers, acts, scenes, verses, etc.

Examination content

Part 1: Group presentation (grading the same for all) (40%):



The group prepares a presentation based on the respective required reading and presents it in plenary. The presentation (20 minutes, max.) summarizes the central aspects of the course reading, reflects them and presents further examples / materials that illustrate the topic area presented. The aim is to present the state of the art re. the topic that is subject to the session of the week.

Part 2: Written term paper (individual) (60%):

At the end of the seminar, the participants write a "take-home exam" (14,000 characters in total, including spaces). This means that the participants have 24 hours to answer the exam questions and submit them electronically. The aim of the term paper is to apply the state of the knowledge about ICT and citizens' political communication and participation that has largely been developed by looking at the OECD world and reflect upon its validity and generability in the context of SSA countries, as we discussed in the seminar sessions.
