#### Course information

#### Course prerequisites

This demanding course builds on introductory knowledge of business strategy and the economic analysis of markets and corporate interaction.

Students with no prior knowledge or experience in economics and corporate strategy are required to familiarise themselves with the basics of these two fields BEFORE the beginning of the course. Students may approach the course lecturer for advice in this regard.

#### Learning objectives

After the successful completion of this course:

- Students will be able to identify corporate strategies and tactics, and understand the difference between them.
- Students will be able to evaluate a company's stated corporate strategy and tactics, appropriately choosing which tools to do so.
- Students will be able to formulate alternative coherent corporate strategies and tactics based on evidence and logic.
- Students will be able to integrate knowledge across different perspectives presented in the class.
- Students will have a better understanding of the environment in which businesses actually operate, not as a theoretical matter but as a practical matter.
- Students will be able to better articulate and defend arguments relating to corporate strategies and tactics.

#### Course content

The overall purpose of this course is to strengthen students' ability to identify, evaluate, and formulate the corporate tactics and strategies of companies in real-world situations. In addition to covering five approaches to assessing corporate tactics and strategies--each backed up with corporate examples or case studies--three sessions of the course will be devoted to the ways in which companies have sought to survive and adapt to the Corona pandemic.

This course will emphasise the application of knowledge--not the rote learning of models and frameworks. As a result, students should expect to prepare before each class session--application of knowledge cannot happen by listening to others speak (passive learning) or in the absence of preparation. If you are not prepared to spend 3-4 hours per week preparing for each class then DO NOT take this course. If you are not prepared to actively engage in class discussions, then DO NOT take this course. If you do not have a strong interest in the private sector then DO NOT take this course.



## Course structure and indications of the learning and teaching design

This course includes 12 sessions, each comprising introductory remarks followed by in-class discussions. Students are expected to attend all lecture sessions and to actively participate in discussion.

Readings must be completed prior to sessions. Preparation for in-class case discussions will require additional research by students before each class. If you are not prepared to spend 3-4 hours per week preparing for each class then DO NOT take this course. If you are not prepared to actively engage in class discussions, then DO NOT take this course.

One two-hour lecture will be held each week. Lectures generally build on the required readings, which will include case study material. Students will be given guidance on how to prepare for the assignments during lectures.

If students seek additional support then additional tutorial or office hour sessions will be scheduled.

## Additional course information

This course is scheduled to be taught face-to-face in the Spring semester, the so-called in attendance model. However, should that model be ruled out for any reason, then the course will proceed in an online delivery format according to university guidelines (e.g., online via Zoom). If you are uncomfortable switching between formats (as may be necessary) or are not prepared to adapt to new circumstances then DO NOT take this course.

## Examination content

The examination of both courses consists of two assignments, each contributing 50% to the final grade:

[1] Decentral examination paper written at home in a group (50%)

Students will be assigned, where possible, into groups of 3 or 4 persons. Over the Spring Break each group will be prepare a 2000-3000 word paper addressing a specific question relating to a certain corporate situation.

This assignment will draw only from the material covered in the first six weeks of the course.

[2] Decentral examination paper written at home individually (50%)

Each student will be prepare a 2000-3000 word paper addressing a specific question relating to a certain corporate situation.

This assignment will draw from the material covered in all twelve weeks of the course.
