This class is open to master students of the University of St.Gallen.

Learning objectives

The Workshop and Lecture Series in Law and Economics allows students to deepen their knowledge in the field of Law and Economics. Students will be introduced to the latest academic research on Law and Economics. They will have the opportunity to engage in the key academic discussions in this field and will be expected to actively participate in these discussions. The course intends to encourage students to critically assess academic research and produce their own research-based written work.

Course content

The Workshop and Lecture Series in Law and Economics is jointly offered by the ETH Zurich and the Universities of Lucerne, St. Gallen and Zurich. It is organized by Elliott Ash, Stefan Bechtold, Gérard Hertig, Simon Lüchinger, Alexander Stremitzer and Alois Schmutzler. It provides an overview of current interdisciplinary research at the intersection of law and economics. Legal, economics, and psychology scholars give a lecture and/or present their current research. All speakers are internationally well-known experts from Europe, the U.S., and beyond.

The workshop and lecture series includes a mix of speakers who represent the wide range of current social science research methods applied to legal issues. In particular, theoretical models, empirical and experimental research as well as legal research methods are represented. It is offered each spring semester.

The papers presented will be made available via the course web page. Participants are expected to have read the papers presented in advance.

Examination content

One decentral written term paper/comment: One comment to a paper of one guest must be written. The comment must be approximately 3000 words long (including footnotes). The comment must be written in English. Comments should relate to one of the background papers posted for a lecture or to a paper to be discussed during a workshop. The idea is not to summarize the paper, but to either shortly comment on one of the issues it deals with or, to the extent it is a working paper, provide constructive criticism about points that deserve further analysis. Comments will not be discussed as such during lectures or workshops. However, students will have ample opportunity to participate in the discussions following each presentation.

Comments must be submitted until 23:59 on the day before the presentation takes place. They should be sent to Dr. Stefan Legge (stefan.legge@unisg.ch). You must submit your comment as a PDF.

Active participation: Students are required to provide one question on at least three different posted papers in advance and engage actively in the course. These questions are meant to be asked during the seminar and have to be sent to Dr. Stefan Legge (stefan.legge@unisg.ch) until 23:59 on the day before the presentation takes place. Furthermore, students are expected to attend 9 out of 12 lectures.
