Learning objectives

Students get advice and a better understanding of how to solve the open issues within their PhD projects in the fields of accounting, auditing, controlling and finance.

Course content

Guided and structured presentation and discussion of students' thesis projects in order to benefit from exchange of ideas.

Course structure

- Kick-off-meeting at beginning of fall term. Achieve common understanding about course objectives and administrative issues (e.g., timing). The kick-off-meeting will be held online.
- Until mid of fall all students summarize their thesis project as one-pager. They also define three to five open points / problems / questions (open issues) they may have. This information will be passed on to all other participants.
- Until end of fall term, each student develops an idea / advice / solution to the individual open issues raised by the other participants. These suggestions will be passed on to all the other students.
- Near the end of fall term, in a block seminar, each students' thesis project, the open issues and possible solutions will be
 discussed. Timing of block seminar will be determined during kick-off meeting. As the number of participants in this
 course traditionally is between 5-10 students only, it is planned to conduct the block seminar in a room sufficiently large
 to meet corona-safety-requirements on campus.
