Course information

Course prerequisites

Interest in political phenomena and in contemporary forms of cooperation states.

Learning objectives

- You acquire empirical knowledge about some important forms of cooperation and integration between states at the regional level
- You are introduced to central economic and political dynamics of cooperation, integration and disintegration at the regional level
- You familiarize with key theoretical approaches to cooperation and integration at the regional level

Course content

The current crisis of integration into or disintegration from the European Union (EU) should not obscure the fact that intergovernmental cooperation at the regional level has been a phenomenon observed around the globe in recent decades. Besides the EU, the best-known projects of regional cooperation are the Common Market of the South in South America (MERCOSUR), the Association of Southeast Asian Nations (ASEAN), the African Union (AU), the Golf Cooperation Council (GCC) and cooperation between Mexico, the USA and Canada, previously known as the North American Free Trade Area, NAFTA to the United States-Mexico-Canada Agreement (USMCA).

The terms regional cooperation and integration refer on the one hand to a densification of economic and societal interactions and on the other hand to the establishment of regional decision-making structures at the regional level. While research on regional cooperation or integration among states dates back to the early 1970s, both changes in the character of existing and the emergence of new regional cooperation projects have contributed to a new boom in research in recent years.

The objective of the course is to acquire the theoretical and methodological foundations that can be used to examine various regional cooperation projects with their commonalities and specifics.

Course structure and indications of the learning and teaching design



We will meet at a weekly basis for sessions of two hours. The seminar starts out with a some of input of the lecturer. In what follows, we will address specific aspects such as institutional set-up and development and policy areas such as security, trade, environment, human rights etc.. Students will work in groups and deepen their expertise on one specific regional project. For each session, two groups will present their findings on the topic of the day while the remaining groups will provide handouts of their project on the topic of the day before the meeting . By so doing, we will be in a position to compare central findings on specific topics in a mixture of presentations and informed discussions.

The examinations are split into four parts:

1. Active Participation during the seminars (individual) (20%)

Students engage in an informed way in discussions

2.Presentation (individual/group, depending on number of participants) (30%)

Groups of students present their findings in max 20 minutes and prepare for the discussion

3. Written Handouts (25%)

The groups that do not present and distribute prepare written handouts on the topic of the day (4-7 pages) that summarize basic information. Handouts must be handed in before the seminar.

4. Essay written at home (individual) (25%)

Students write a small essay (about 3000-3500 words) in which they address a key aspect of the seminar in a comparative way, i.e. by addressing at least three projects of regional cooperation and integration.
