# **Course information**

### Course prerequisites

# Learning objectives

You know and understand Swiss Private Law's main features, its sources, structures, basic principles and scope of application.



You are able to apply your knowledge to practical cases.

You are able to analyse contract and company law problems, identify the legal difficulties as well as to formulate concise and law-based solutions.

### Course content

- 1. Overview of the Civil Code (CC) and the Code of Obligations (CO) (including the introductory articles to the Civil Code, private law subjects, fundamental principles of contract law, origins of obligations)
- 2. Creation of obligations (including freedom of contract, conclusion of contracts, validity of contracts, error and fraud, agency)
- 3. Performance of contracts in general and in the case of specific contracts
- 4. Breach of contracts (including default of obligors and obligees, non- and misperformance, liability for auxiliary persons)
- 5. Company law: principles and types of companies (emphasis placed on Simple Partnerships and the Company Limited by Shares)

# Course structure and indications of the learning and teaching design

The course is subdivided into several modules and consists of lectures, exercises, tutorials and supporting learning materials.

### Lecture

In the lecture students will learn the basics of Swiss private law, namely contract and company law. The details of the course structure and respective content will be communicated on Studynet (Canvas) in due time.

### Exercises

The students deepen their knowledge by solving pratical cases.

### **Independent Studies (Tutorials)**

The tutorials offer a chance to clarify questions regarding the literature as well as the lecture content and to deepen the theory with case examples. The cases build upon the lectures. You should, therefore, prepare the literature and lecture on the respective module before attending the tutorial class.

### Supporting learning materials

Besides literature, lecture, exercises, tutorials, other multimedia learning materials are provided on StudyNet (Canvas) and YouTube. They allow you to deepen your knowledge and prepare for the exam.

### Examination-aid rule

Extended Closed Book for Examinations in Law

The use of the examination aids is restricted. In addition to the principles set out in this section, other permitted examination aids must be listed exhaustively in the section "supplementary aids".

The following applies in principle:

- All calculators of the Texas Instruments TI-30 series as well as monolingual or bilingual dictionaries (not specialised dictionaries) without hand written notes are accepted. All other calculator models and electronic dictionaries are not allowed;
- Furthermore, any kind of communication and all programmable and communication-capable electronic devices such as notebooks, tablets, mobile phones etc. are not permitted;
- The procurement of examination aids is the sole responsibility of the students;
- All official federal enactments in the four national languages and in the English translation of the Swiss Federal Chancellery as well as the official enactments of the Canton of St.Gallen are always permitted. The decrees that are required for the examination are listed under the heading "examination aids-rule";
- Additional examination aids and private collections of enactments are only permitted if they are explicitly listed in the
  examination aids-rule. This is an exhaustive list. Any private collections not listed are expressly prohibited and will be
  confiscated without substitution, regardless of whether they are commented, uncommented or annotated legal editions;
- Unless otherwise defined in the examination aids-rule, all permitted documents may be combined in any number and language.

The following preparation of the legal texts is permitted:

- References to other articles of the law, including all designations and numbers as they appear in the permitted legal texts (e.g: Art 62 ff. OR4 / Art. 164 para. 1 lit. a BV5 / Art. 25 para. 2 lit. a no. 8 MWSTG6 / Art. 158 BV in connection with Art. 4 ParlG7 / Art. 29 II BV etc.), these must be written in a national language and/or in English;
- Markings with any kind of pens including highlighters in different colours (e.g: underlining, encircling, special characters like arrows, stars, etc.). Systematic marking of individual letters is not permitted, and all other notes and comments are also prohibited;
- Registers: Self-adhesive labels in the margin of the respective legal text are permitted, but they may only be used with the marginalia, titles, articles (e.g: Art. 141 BV: Optional referendum or 5th title: Federal authorities or Art. 5 BV) of the relevant page.

Print-outs and copies of legal texts approved (i.e. all official editions or permitted private collections including tables of contents and subject indexes) must correspond 1:1 to the original; the original source must be clearly traceable.

Older editions are allowed as well but not recommended as they might contain provisions that are outdated. Please be aware that on 1st of January 2023 the revision of the company law comes into force.

The official statutory texts and the English translation by the Federal Chancellery are admitted as well. It is uncertain whether the official translation of the revision of the company law will be available during the fall semester 2022. Please refer to the general rules on examination aids (see above) for the admissibility of the **official statutory texts** by the Federal Chancellery. You may download and print the official statutory texts from <u>www.admin.ch</u> or buy the print version of them at a bookstore or from the Federal Chancellery.

If you print the statutory provisions from admin.ch, note that the source of these printouts must be clear. We recommend that you print the PDF version. You may rescale the pages to fit the paper you use.
