Course information

Course prerequisites

There are no official prerequisites for this class although students should have a good command of the English language as the readings and lectures are in English.

Learning objectives

At the end of the semester students will be able to identify the major traditions of American strategic thought as well as the periods during which each was dominant in US foreign policy. Students will also be able to apply basic models of International Relations and foreign policy decision-making to the analysis of historical events.

Course content

How did thirteen relatively weak British colonies secure their independence and rise to the status of a great power within the space of 100 years? How did the only North American great power go on to become one of the 20th Century's two global superpowers and come to dominate the international system at the start of the 21st Century? This course analyzes the rise of American power in light of American Grand Strategies. The history of American foreign policy is used as a case study against which to evaluate leading theories of international politics, in particular the operation of the Balance of Power.
