Course information

Course prerequisites

None in terms of prior knowledge. Ability to participate in person on campus on all three seminar days in November.

Learning objectives

To better understand (i) why some countries fail and (ii) whether and how they could succeed in terms of economic development and political inclusion.

To learn how to conduct research in a difficult, data-scarce context.

Course content

Failed (or fragile) states cannot control their territory or have lost the monopoly on the legitimate use of physical force, and they are unable to provide basic public services. Therefore, they host many of the worst-off individuals in the world, and they are the source countries of asylum seekers and, sometimes, transnational terrorists.

We proceed in three steps: First, students study possible root causes for the failure of individual countries. Second, they develop some hypotheses on root causes and potential remedies. Third, they test these hypotheses using quantitative or qualitative methods.

Course structure and indications of the learning and teaching design

There will be an introductory lecture on Zoom and three full seminar days on campus. On day 1, students present and discuss their country studies. On day 2, students develop and test some hypotheses on root causes and potential remedies. On day 3, students present and discuss these tests.

Some introductory texts will be provided on Canvas; students are expected to search for and read other material.

Written work must be written without outside help according to the known citation standards, and a declaration of authorship must be attached, which is available as a template on the StudentWeb.

Documentation (quotations, bibliography, etc.) must be carried out universally and consistently according to the requirements of the chosen/specified citation standard such as e.g. APA or MLA.

The legal standard is recommended for legal work (cf. by way of example: FORSTMOSER, P., OGOREK R., SCHINDLER B., Juristisches Arbeiten: Eine Anleitung für Studierende (the latest edition in each case), or according to the recommendations of the Law School).

The reference sources of information (paraphrases, quotations, etc.) that has been taken over literally or in the sense of the original text must be integrated into the text in accordance with the requirements of the citation standard used. Informative and bibliographical notes must be included as footnotes (recommendations and standards e.g. in METZGER, C., Lern- und Arbeitsstrategien (latest edition)).

For all written work at the University of St.Gallen, the indication of page numbers is mandatory, regardless of the standard chosen. Where page numbers are missing in sources, the precise designation must be made differently: chapter or section title, section number, article, etc.

Active classroom participation

In the "Active classroom participation" examination form, regular participation in class is assessed.

The assessment criteria can be as follows:

- Requests to speak enrich the discussion (productive) / requests to speak disturb the discussion (counterproductive);
- Requests to speak are correct/requests to speak are incorrect;
- Requests to speak are frequent/average/rare;
- No requests to speak, but students follow the lesson/no requests to speak and students do not noticeably follow the lessons.
