Learning objectives

During the course the following learning objectives should be achieved:

- Students develop basic knowledge and skills to read, classify, understand and write scientific documents;
- Students learn skills needed for writing their own scientific work. This includes among other things
 - Finding and narrowing down the topic and formulating the research question;



- Conducting literature research and evaluating sources;
- Citing scientifically and managing literature;
- Structuring scientific work and understanding its components;
- Understanding concepts of scientific language;
- Being able to assess the formal and content-related quality of a scientific paper;
- Students write two training papers as well as their own seminar paper and apply the learned concepts to their own content;
- Students implement feedback from lecturers and fellow students.

Course content

The course provides an introduction to the demands and conventions of academic writing. The course focuses on the development of key competences, such as acquisition, structuring and sharing of knowledge in accordance with the academic writing conventions. Academic writing skills are necessary for the successful continuation of studies, which can at the later stage be applied at the workplace. Ability to work independently, to critically evaluate the content and to reflect on the writing process - all contribute to successful development of academic writing competences. The course focuses on the development of specific academic writing competences, which students can immediately apply to a written project as part of the course:

- 1. Find and narrow a topic / develop a research question
- 2. Research and working with sources
- 3. Academic quoting
- 4. Build an effective and logical structure
- 5. Develop effective argumentation
- 6. Apply the formal aspects to your academic writing

Course structure and indications of the learning and teaching design

The course consists of two main learning components, the self-directed study and teacher-taught learning. Teacher-taught learning consists of one lecture (kick-off) and learning in smaller groups in seminars (6 sessions). The teaching/learning design is based on the flipped classroom approach.

Course literature

There is no specific textbook for the course. All information on the course as well as text excerpts from relevant literature on academic writing are made available on the learning platform. The books from which the excerpts are taken are available for reference at the University of St.Gallen Library.

Examination-aid rule

Free aids provision

Basically, students are free to choose aids. Any restrictions are defined by the faculty members in charge of the examination under supplementary aids.

Supplementary aids

Written work must be written without outside help according to the known citation standards, and a declaration of authorship must be attached, which is available as a template on the StudentWeb. Documentation (quotations, bibliography, etc.) must be carried out universally and consistently according to the requirements of the chosen/specified citation standard such as e.g. APA or MLA. The legal standard is recommended for legal work (cf. by way of example: FORSTMOSER, P., OGOREK R., SCHINDLER B., Juristisches Arbeiten: Eine Anleitung für Studierende (the latest edition in each case), or according to the recommendations of the Law School). The reference sources of information (paraphrases, quotations, etc.) that has been taken over literally or in the sense of the original text must be integrated into the text in accordance with the requirements of the citation standard used. Informative and bibliographical notes must be included as footnotes (recommendations and standards e.g. in METZGER, C., Lern- und Arbeitsstrategien (latest edition)). For all written work at the University of St.Gallen, the indication of page numbers is mandatory, regardless of the standard chosen. Where page numbers are missing in sources, the precise designation must be made differently: chapter or section title, section number, article, etc.
