## Learning objectives

Understanding the very nature of law

Understanding different theories about the foundations and prerequisites of law

Understanding different methodological approaches and their impact on legal interpretation

## Course content

The target audience of this course on offer in the MIL programme are students who either did not have a legal education, e.g. students who move into the MIL laterally, or did not have the opportunity to deal with classic jurisprudential questions and topics during their legal studies and hence could not engage with general questions about the very nature of law. In this course we will encounter a few of these very general questions. What is law? What is the purpose of law? Is there a connection between law and morality? What role do judges and lawyers play in shaping the law? What are the foundations of legal interpretation?

The goal of this course is to broaden and deepen your knowledge about law and give you a solid basis for your further legal education in any given field (national law, European Union law and international law including all their sub-branches).

## Course structure and indications of the learning and teaching design

The course will take place during the first half of the autumn semester and will consist of two 90 minutes units per week with lectures, interaction, and discussion.

Students are not required to give presentations in class, but active participation and interaction is compulsory. We intend to have colloquial atmosphere with a seating order, so that I can adress the students by name.
