Course content

What can you learn from Al Pacino about effective strategy presentations? What can Confucius teach us about memorable team instructions? What African ritual can serve as a model for sustainable conflict resolution? More specifically: How can you be persuasive in different cultures? How are meetings different in France, China, The US, UK, Arabic nations, Scandinavia, Switzerland or Italy? How can we use visualization to communicate complex contents?

These are a few of the questions that we will discuss in this interactive, hands-on class. The course is easy on readings, but heavy on in-class exercises and experiments. It is based on theoretical insights that are made actionable through cases, discussions, experiments, and exercises. Other questions that we will tackle regard how to make your messages stick, how to meet (differing) presentation expectations in different cultures or how to overcome or avoid PowerPoint fatigue and use alternative (visual) presentation tools.

Goals

The course on global managerial communication introduces students to one of the most frequent tasks in management - leading



effective dialogues. It provides an overview on the rich theory on managerial communication, particularly in knowledgeintensive, complex, and intercultural situations, and sensitizes students to the challenges of management communication, ranging from leading interdisciplinary teams, giving feedback, asking the right questions to spark innovation, to leading meetings in different cultures or interacting with potential clients or conducting negotiations. The main goals of the course are thus to build a solid understanding of the key mechanisms that shape effective managerial communication in a global context and understand its potential pitfalls, as well as to learn about effective practices of leading communication on an interpersonal and group level.
