#### Course information

### Course prerequisites

There are no prerequirements for this course. Familiarity with the basics of International Relations (IR) theory combined with a solid interest in security studies and the Indo-Pacific region will be an advantage.

### Learning objectives

In this course students will demonstrate the ability to:

- critically reflect on the emerging concept of the Indo-Pacific from a security perspective;
- independently conduct a systematic analysis of a specific security issue or challenge related to the Indo-Pacific;
- discuss an analysis of Indo-Pacific security issues and challenges performed by others.

#### Course content

This thematic MIA course, part of the "Security and Conflict" cluster, deals with an emerging mega-regional security landscape of global importance: the Indo-Pacific. Still a rather ambiguous and contested concept, the idea of the Indo-Pacific as a geopolitical entity has gained traction in recent years.

This vast region has become the central theatre in the strategic competition between the United States and China to shape the course of the  $21^{st}$  century as well as the attempts of regional great powers such as Japan and India to find an answer to the economic, political and military rise of China. The region is also home to security flashpoints that could have global ramifications, including the Korean Peninsula, the Taiwan Strait, and the South China Sea. Furthermore, the Indo-Pacific countries are increasingly confronted with new security challenges emerging from a host of transnational threats. At the same time, economic interdependence among regional states remains high, and there are multiple efforts to build regional institutions aimed at mitigating conflicts and increasing the benefits of inter-state cooperation.

Drawing on International Relations (IR) theory, this course will critically review the emerging concept of the Indo-Pacific from a regional security perspective, with special emphasis on the specific interests, approaches and strategies of great and middle powers such as the US, China, India, Japan, Australia, and others.

#### Course structure and indications of the learning and teaching design

The course meets every two weeks for 4 hours on the campus. It consists of two main parts comprising three sessions each:



- The first part before the semester break will focus on the conceptual underpinnings of Indo-Pacific security and provide background knowledge on the topics proposed for the term papers. It is taught in the form of lectures supplemented by short break-out group and plenary discussions.
- The structured discussion of the topics dealt with in the terms papers is at the core of the second part of the course. Each term paper is presented in class, evaluated by assigned discussants and further discussed in the plenary. If time permits, this part will conclude with a role play in the form of an Oxford Debate.

The course will include a couple of (online) guest lectures by external experts from the Indo-Pacific region sharing their perspectives on the course topic.

Active participation of the students is required throughout the course, including (but not limited to) the presentation and discussion in class of term papers.

#### Course literature

Required reading for all course participants and a selection of introductory reading related to the topics proposed for term papers will be made available on StudyNet by the beginning of the semester.

Although there is no compulsory textbook for this course, students may wish to use the following book for preparatory reading:

He published widely on Asia-Pacific security (focusing on Southeast Asia), inter-regionalism (focusing on Asia-Europe relations), and security governance (focusing on security sector reform).

# **Examination content**

*Term paper:* to be written by groups of students on one of the topics proposed by the instructor. Allowed group sizes are determined at the first session. The topics of the papers are assigned to the groups following the first meeting. Term papers must be submitted by November 8<sup>th</sup>, 2023, at 8am.

*Presentation:* includes (a) the presentation of the term paper in class and active participation in the plenary discussion by the assigned groups at one of the sessions in the second half of the semester and (b) the presentation in the role of discussants of a critical evaluation of a term paper prepared by another group.
