#### Course information

#### Course prerequisites

There are no prerequisites for this course except genuine interest in foreign policy

#### Learning objectives

- Deeper understanding of the functioning of foreign policy
- Appreciation of International Law and the rules based international order
- Deeper understanding of individual conflicts
- Ability to develop options for foreign policy actions

#### Course content

After the horrors of the Second World War the International Community was determined to prevent similar conflicts in the future. The UN were founded. The understanding was that future conflicts should be resolved peacefully, based on the strength of the rule of law and not through the rule of force exercised by the strongest. Currently, we are experiencing a crisis of the Rules Based International Order. Many international players simply ignore International Law. We observe this in Ukraine, in the Sudan, the Middle East and in other places. The course will look at the basis of the Rules Based International Order and individual crises where the Rules Based International Order is under attack.

#### Course structure and indications of the learning and teaching design

The Block Seminar will contain 7 main sessions:

1. Overview of the Rules Based International Order: UN Charter and Security Council Resolutions, Universal Declaration of Human Rights, International Courts, other components of International Law
2. Russia's war against Ukraine
3. The Cyprus conflict
4. The conflict between Serbia and Kosovo
5. Haiti: the way forward



6. The Sudan crisis

7. The Middle East Question: Two-State-Solution or else?

Each session will be introduced by Christoph Heusgen. He will then invite an international personality to present her or his view of each topic. A discussion on the conflict will follow. Dependent on the number of students participating in the course adaptations will need to be made (more group work vs. individual work). After the number of students inscribed is known more detailed information on course work and examinations will follow.

## Course literature

There is no specific book to be read beforehand. Students should read newspapers, magazines, do some individual research on the conflicts. Everybody should look at the UN Charter.

## Additional course information

Christoph Heusgen was foreign policy advisor to German Chancellor Angela Merkel for 12 years (2005-2017) and then Germany's Ambassador to the United Nations for four years. Since February 2022 he is Chairman of the Munich Security Conference. He has extensive practical experience with the course topic.

## Examination content

Students are expected to demonstrate a deeper understanding of on one of the themes of the six sessions (see above sessions 2-7). What are the interests involved of the parties, of outside actors? What are constraining factors? What are possible solutions, ways forward?

### Groupwork Paper (50%)

Participants will be divided up into six groups and work on one of the issues 2-7 (see above). Students give an oral group presentation on their topic during the block seminar, which is then reviewed by the respective expert via video. On this basis, they then prepare their final group paper.

### Individual Final Paper (50%)

In addition, students are expected to write individual papers (up to 5 pages) on an aspect of the subject of their group papers.

## Examination relevant literature

There is no mandatory literature or specific books. The components of international law applicable to the conflicts should be known. Current developments on the conflicts should be followed.
