Course information

Course prerequisites

There is no pre-requisite for this class. Basic knowledge in Economics and UE institutions are a plus.

Learning objectives

- The course will focus on the modalities of implementation of green industrial policies in the European context and encourage the students to discuss how green industrial policies may foster or impede the green transition.
- The students must encounter different and divergent perspectives in order to be adequately prepared for the interconnected, complex world in which they live and operate, the course will build on the literatures in international political economy, economics, law and business studies.
- The class will thus provide students with the analytical and empirical tools necessary to understand the complex challenges of the role of the state in fostering green finance, as well as with insights as to how integrate this complexity in effective decision-making.

Course content

- The green transition is not just a technical challenge, it is embedded in a complex web of private and public institutions at the domestic and international levels that may foster as well as challenge its enactment. The class will focus on how the green transition may be fostered or hindered by the implementation of industrial policy by states, which include the pursuit of goals such as growth, geo-economic advantage or the defence of national sovereignty. Building on the literature in international political economy and public policy, the class will provide students with the analytical and empirical tools necessary to understand the challenges of the green transition in a holistic way, as well as with insights as to how integrate this complexity in effective public policymaking.

Examination content

There are three parts: a written individual memo (40%), a group policy report (50%), and a participation grade (10%),



- The students write the **memo** at home about a specific area discussed in a class session, based on the readings. Within one week, students are required to immerse themselves into the subject matter of the problem assigned and formulate a reflected though "rough and ready" assessment of the question posed.
- The group **policy report** requires a substantiated engagement with one aspect of green industrial policy (a list of topics will be provided). The expectation is that students assess the problem from the perspective of different actors and weigh against disciplinary perspectives against each other and, finally, provide a decision with reasons.
- The **participation** grade rewards written (e.g in the discussion threads) and oral engagement in the class.

An exact description of the tasks and the expectations will be provided with the publication of the tasks.
